TOPICS DISCUSSED:

- Roger provided a revised proposed budget to the group.
- Saeed is working with the State finalizing the following:
 1. Official "League" name change from *Super Soccer League* to **Elite Soccer League of Nevada.**
 2. Officers signed necessary documents for the League's "Board of Trustees" as follows:
 - Saeed Bonabian Preident
 - Todd Abdalla Vice President Compliance/Discipline
 - Ric Grenell Vice President Competition
 - Michael Thompson Treasurer
 - Rich Ryerson Secretary
 3. Change language in the league constitution- took out "competitive" and replaced with "highly organized"
 4. Saeed will e-mail the final Bylaws and Constitution.
 5. Monday have an I.R.S. tax identification number and checking account.
 6. Sally accepted the position and will begin June 16th.
 7. Office space is ready...signing the lease.
- Todd had questions:
 - Age variations necessary to be accepted in "Club" status to which everyone agreed. We will add 11 and above to the 8 team requirement. National standard is u-6 thru u-10 developmental and u-11 competitive.

- Other discussion:
 - Status of John Kennedy as an assigner. (His status in the state and fee structure.)
 - Status of Premier...they will have teams playing at various levels.
 - Adjustment of league web site reflecting various fee levels based on participation/season of sport with an allowable cross-over window to join the league.
 - Pushback from the existing leagues
 - Not in compliance with the State
 - Legitimacy questioned
 - Not registered with the State
 - We need representation at the State AGM Meeting 6/29/09

- ✓ Todd-will begin working on a Disciplinary Policy document.
